## Jonathan misrepresents our city's jurisdiction, and doesn't understand how our city operates

✗ Everyone wants the hospital to reopen, but Jonathan believes the Council can wave a magic wand to make it so. He advocates using City money to open the hospital. *The hospital is governed by an independently elected Board, over which the Council has no control.*

✗ Everyone wants the library to restore services, but Jonathan mixes apples and oranges. He advocates that the City fund just the Sebastopol Library. *The library is governed by an independent County body over which the City has no control.*

A few more things Jonathan doesn't understand: Ask him about the General Plan update – our blueprint for the next 20 years – he doesn't understand the process or its importance. Ask him about how much money it takes to run the city, and about what our dedicated staff and public safety members earn. Ask him about bicycle lanes – he doesn't understand that building bicycle lanes takes studies, planning, and coordination with state and federal agencies. Jonathan doesn't understand what it takes to keep our city functioning.
